MTDC equals total direct costs less the following exclusions: capital expenditures; any amount over the first \$25,000 of each subcontract (aka, subrecipient agreement) issued by Case; hospitalization and other fees associated with patient care whether the services are obtained from an owned, related or third party hospital or other medical facility; rental/maintenance of off-site activities; student tuition remission and student support costs (e.g., student aid, stipends, dependency allowances, scholarships, fellowships).

OVERHEAD RATES - TRAINING
